The Chair's annual report was as follows;

This past year has been challenging in many ways, particularly with the issues we have had to face at Little Wood, and a huge deal of thanks must go to Cllr Hudson and volunteers for his efforts in continuing to address these issues and I am hopeful that progress can continue to be made to ensure that the area can be used safely again.

I am also confident that through the support of volunteers, we will be able to continue the work on the field at Frith Avenue. Thanks to Harry and John (Ward Councillors), we are now in a position where we are hopefully able to select various sites in the community to grow wildflowers later in the year.

Over the coming years we are also faced with the ongoing developments with regards to the United Utilities Lake Vyrnwy restoration programme, which will inevitably bring a great deal of disruption to Delamere and Oakmere. Although previous meetings with United Utilities have been somewhat useful and informative, I hope that the meetings will continue over the course of the next year so we are able to feed this back to the community.

Through the support of our new PCSO and Cheshire West I am also hopeful that we can address some of the key areas of concern for residents in relation to road safety, particularly the areas surrounding Delamere Academy and on Station Road.

Cheshire West and Chester Ward Councillor J Leather will investigate this on behalf of the Parish Council.

The clerk confirmed that she had ordered the wildflowers and the cost of this was £243.99 and the cost of the compost ordered was £192.00. Locations for the wildflower planting will be considered at the next Parish Council meeting as an agenda item.
